REGULAR MEETING

Special Called Town Meeting December 29, 2017 2:00PM

The purpose of this meeting is to accept the Land Donation Agreement and Property Deed from Betty and Jack Lail and the other leases that were established by them.

Those attended this meeting were: Mayor David Fernandez, Mayor Pro-Tem Cindy Neef, Commissioner Sandra Walker, Commissioner Ed Walker, and Commissioner Jason Auman.

1) The first order of business is to accept the Land Donation Agreement from Betty and Jack Lail. There was one change to the document in Section 6.4. 'The driveway separating the Property from the entirety of the site shall be named by the Town and designated as a street to be maintained by Town. Town will begin process of extending the street to NC 705 on the east of the Property within 3 years.'

Commissioner Sandra Walker asked, what is the intended purpose of this road extension around the building? Mayor David Fernandez stated that this would give Sapona another access to their property and would give the town another access around the back of Town buildings. The Seagrove/Ulah Metropolitan Water District has an easement to this section and wondered if they have been notified. Mayor David Fernandez stated he had talked with Mike Walker on this subject. He also stated we are not committed to complete the street around the building but to start the process having a city street between the buildings. The attorney recommended that we take 3 years to work on this process. Sapona has a gate and will move it to another area. This street will increase our Powell monies. Motion to accept this agreement by Commissioner Jason Auman, Mayor Pro-Tem Cindy Neef seconded. Vote was unanimous.

- 2) Discussion of T&D Solutions, LLC. Effective May 1st, 2017. They are leasing 9,000 square feet of the premises for commercial use parking their trucks. The first rent of \$260.00 was released to the Town from JBDL, LLC. This is the agreement set forth in the lease for the Town to receive monies for said premises.
- 3) Discussion of GroundLion Brewing leasing of property. They will rent approximately 10,493 square feet of the premises for their brewing processing. The agreement from JBDL, LLC that GroundLion was given 1 year free rent in exchange for \$10,000 in renovations within their said section of the premises. It is a 5 year lease and after the first year, the rent will be approximately \$1,000 per month. Mayor David Fernandez has asked JBDL, LLC for the contract that was signed by both parties to have on file. The 15th of September was the beginning of their lease.

Motion to accept the properties from JBDJ, LLC was made by Commissioner Ed Walker, seconded by Commissioner Sandra Walker. Vote was unanimous. All this needed to be signed and registered by 5:00PM.

Other discussions, in Section 6.10 of the Land Donation Agreement, Mayor David Fernandez discussed the requirements. 'The Town shall create an advisory development committee focused on the use and maintenance of the Property. The committee shall compose of: one member from the Town Council, one member of the local business community, one member at large, one member from each of the two major donors, and one member from the pottery community. This committee shall administer the Luck's Cannery Naming Policy.' The convention center was requested to be named after Mrs. Wavie Presnell. The Presnell Foundation donated \$25,000 to the cause. Half will be paid to the Town this year and the other half next year.

More discussion was given on the renovations and when the Town can move in the New Town Hall.

Motion to adjourn the meeting, made by Commissioner Sandra Walker, Commissioner Jason Auman seconded. Vote was unanimous.
