MINUTES

REGULAR MEETING DECEMBER 3RD, 2019

The meeting was called to order at 6:02 p.m. by Mayor Fernandez. Those present were, Mayor Pro Tem Cindy Neef, Commissioner Pam Allen, Commissioner Sandra Walker and Commissioner Jason Auman. Commissioner Ed Walker was absent.

Mayor Fernandez took a moment to recognize and thank the outgoing Commissioners and commend them for their service to the town.

A. Swearing in of new Commissioners

The Town Clerk swore in three new commissioners to the Town of Seagrove. They will be replacing outgoing Commissioners Pam Allen, Jason Auman and Sandra Walker.

The new Town Commissioners are:

B. Election of Mayor Pro Tem

Commissioner Homer Beheler motioned to elect current Mayor Pro Tem Cindy Neef as Mayor Pro Tem for the remaining term.

2nd by Commissioner Kathy Fernandez

The motion passed.

C. Approval of Minutes

G. Open Meetings Law/Conflicts of Interest Discussion with Town Attorney

The board heard from the Town Attorney, Lucas Horner, about the laws pertaining to what is considered an official meeting of the board, especially since the board members are all close neighbors and associate in many of the same social circles. This review is to ensure that all members of the board and the public are aware of proper protocol when multiple members of the board are together outside of official town meetings. For example, if multiple Commissioners are in the same building/social gathering/event at the same time it is most likely

OK, as long as they do not discuss town business. The more people on the board and the purpose for getting together will determine whether or not it is official. Another example – if the board members all decide to attend an event with the purpose of fundraising for the Luck's Cannery, then that would be considered an official town meeting. Another example - If the board members are working together on a specific project, like the Christmas event, that would be considered more executory and therefore OK because they are carrying out decisions already voted on by the board and not making any legislative decisions.

They also discussed potential conflicts of interest when hiring outside contractors for the Town. As Seagrove has a population under 15,000, it is OK for members of the board to be hired or have a financial/personal/familial benefit as a contractor under a certain monetary threshold depending on the goods/services provided. It is also best practice to recuse themselves from the vote if they feel that there is a conflict of interest, though not legally required. All newly elected Commissioners are required to take Ethics Training – the course is offered through the UNC School of Government in December.

H. Christmas Event Discussion

Mayor Fernandez had local Scouts clean the Train Depot to prepare for the event. He has also received in numerous donations from local businesses and people around town for the event. We are taking on two families from the school and purchasing gifts for them for Christmas.

Mayor Pro Tem Cindy Neef had a few questions to confirm about the event.

- The town has secured Christmas lights and confirmed that Dennette Lilly coordinates with someone to decorate the tree with ornaments.
- A schedule was confirmed to put the lights on the tree, prepare and decorate for the event and transport all gifts for the event before the parade on Saturday December 7th at 4:00pm.
- Currently have 8 bikes purchased. The Town is planning on purchasing more for the event. Commissioner Kathy Fernandez and Commissioner Homer Beheler agreed to pick up more bikes for the event.

I. Approval of Luck's Advisory Committee Recommendations

Per the meeting on 11/5/19 – the board approved the spending of \$100,000 as needed for renovations and at the meeting on 10/1/19 \$4,000 for Terry's Plumbing was approved to complete the demolition work still needed. The following items are included in this approval:

- The Luck's Advisory board has approved spending of approx.. \$55,000 for The Glass Shop in Lexington, NC to install glass doors for storefronts.
- The Luck's Advisory board has approved spending of approx.. \$41,000 for French Drain, concrete renovation, and the additional work that Terry's Plumbing had not completed (\$4,000); however, the town has decided they would like to wait on contractor decision for an additional bid before moving forward.

The approval of spending for JBDJ LLC/First Line Plumbing for \$40/labor hour (estimated hours 400hrs) and material costs with 12.5% mark up from First Line Plumbing to install plumbing fixtures in lower level was motioned by Commissioner Homer Beheler.

2nd by Commissioner Carol Kim

The motion passed.

J. Committee Reports

Nothing at this time due to new Committee assignments.


Mayor Fernandez mentioned that the Scouts will be camping at the park this weekend and will facilitate a trash pick-up through out to help keep the park clean.
